**Plan for Jerusalem Tour (Tuesday):** 2.5 hour outdoor walking tour in a world-historic setting. Be sure to bring head-covering, comfortable walking shoes, and dress in a manner appropriate for visiting holy sites.

We will begin our tour next to Notre Dame Abbey to see and discuss the border that once ran through Jerusalem.

We will enter the Old City through Damascus Gate and visit the Austrian Hospice of the Holy Family to enjoy a rooftop view of the Old City.

We will see some of the stations of the Via Dolorosa and some of the historic structures of the Muslim Quarter, and visit the Western Wall, the place of Jewish prayer. From here we will walk through the Jewish Quarter and its archaeology on route to the final part of our tour in the Christian Quarter and the Holy Sepulcher Church.

Visiting Muslim, Jewish and Christian quarters we will explore the connections and relations between these faith groups and their part in building the city.
